Sole Proprietorship (*Pemilik Tunggal*)



- Known as Sole trader or Proprietorship
- One owner
- Simple
- Unlimited liability
- Personally responsible for all losses & debts

Partnership (*Perkongsian*)

- Business Entity having 2 – 20 partners
- Partners are personally liable for the partnership's debts and losses incurred by themselves
- A partnership is not a separate legal entity from its owners



Company (*Syarikat*)



- It has a legal personality
- Can be defined as ‘Artificial person’
- It can sue or be sued in its own name
- Identifiable by the words “Sdn Bhd” and “Bhd”
- Subject to pay to Corporate Income Tax.

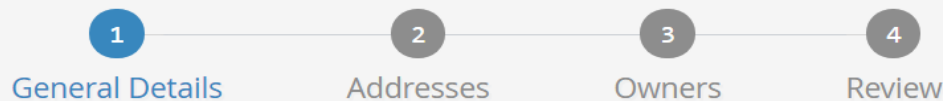

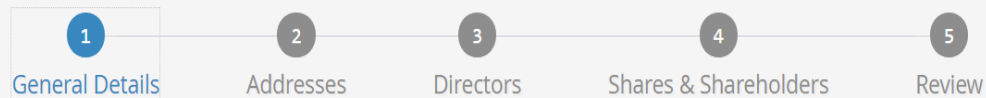
